Emma Dorn Global Education Practice Manager McKinsey & Company

Emma Dorn is the Global Education Practice Manager at McKinsey & Company where she supports McKinsey's education work across early childhood, schools, vocational training and higher education. Emma has significant experience in

global education, US K-12 schools, education technology, economic development, and global health sectors, as well as broader philanthropy, donor and nonprofit functional expertise. She also has expertise in applying advanced analytics for social impact.

Emma led McKinsey's response to COVID-19 for school systems. This involved working with UNESCO's Global Education Coalition to develop global toolkits for countries to plan and execute their education response to COVID-19 including remote learning, hybrid learning, reenrollment, remediation, and organizing the response. Emma also supported US states and school districts to understand and apply

best practices for reopening elementary and secondary (K-12) schools for in-person, hybrid and remote learning. Previous work includes advising global private sector education players on market landscape and mapping, and supporting higher education institutions to leverage advanced analytics to improve decision-making.

Emma writes frequently on education issues across school systems, higher education and workforce development, and speaks at global conferences and events. Recent knowledge contributions include:

Outside of McKinsey Emma has taken a variety of positions in International Aid and Development organizations. She was Acting Executive Director of Millennium Promise, an organization set up by Jeffrey Sachs and Ray Chambers with the vision of achieving the Millennium Development Goals by 2015. She was responsible for the early implementation of the Millennium Villages Project, a community-based integrated development project in 10 countries across Africa. Emma has also worked as a stagiaire in the European Commission's Development Directorate (Health, HIV/AIDS and family planning unit); as a Business Development Advisor for TechnoServe Tanzania, and as an Advisor to the Social Fund of the Democratic Republic of the Congo.

Emma holds an M.B.A with high distinction from Harvard Business School and a B.A. in Geography / Development studies from Cambridge University, UK.

Dr. Jennifer McCombs is a senior policy researcher and Director of the Behavioral and Policy Sciences Department at the RAND Corporation. Her

research combines implementation and outcome data to provide practitioners and policymakers guidance on how to improve programs and promote positive outcomes. Aaron Dworkin CEO National Summer Learning Association

Aaron joined the National Summer Learning Association as Chief Executive Officer on June 3, 2019 having most recently served as President of the After-

School All-Stars National Network – a non-profit organization providing free afterschool and summer programs to 90,000 low-income students in more than 450 Title I schools in 20 major cities across the United States. Over the last 12 years, Aaron led the organization through tremendous growth, significantly increasing the number of students served, doubling the After-School All-Stars national

footprint and annual revenue, while opening a national office in Washington, D.C. to expand its advocacy efforts.

Aaron also oversaw the creation and implementation of the After-School All-Stars' four signature national initiatives, each with their own summer learning program, designed to combat childhood obesity (Sports as a Hook), promote high school and college graduation (We Are Ready), prepare students for careers (CEO: Career Exploration Opportunities) and inspire youth leadership and community service (Life Service Action).

Prior to After-School All-Stars, Aaron founded and directed Hoops & Leaders, an acclaimed summer youth leadership and mentoring program in New York City. He also helped support the creation of Up2Us Sports, a national coalition of sports-based youth development programs. Aaron is a frequent presenter at national education conferences, a graduate of Tufts University, a former Coro Fellow in Public Affairs and holds master's degrees from Columbia University's School of International and Public Affairs, and Harvard University Graduate School of Education. He is a member of the 2019 Class of Leadership Greater Washington and serves on the National Board of Directors of the American Camp Association.
