In addition, he has worked in many countries from Brazil to South Korea and from Mongolia to Australia.

He currently is the Education Consultant to the CS Mott Foundation and Senior Fellow for the Riley Institute at Furman University. He co-chairs the Afterschool Alliance, and chairs the national White Riley Peterson Afterschool Leadership Fellowship.

Stacie holds an MBA from the University of North Carolina – Chapel Hill and a Bachelor's Degree in Psychology from the College of Charleston, SC. She has twice been named one of the Top 100 Women in

Maryland, is an alumna of the Greater Baltimore Committee's Leadership Program, has held multiple positions on National YA Board Committees, and has served on the Maryland State Department of Education's Fine Arts Panel. She has also served two terms on the Greater Baltimore Cultural Alliance Board. She currently chairs the Executive Committee of a collective effort to create a National Teaching Artist Certification Program for the field.
